





DUES COLLECTION

Dues Collection

Annual membership dues are currently collected on the anniversary date for the individual member. That involves considerable work for the Membership Director and for the Treasurer as each individual must be tracked at different dates of the year, and follow up communications done as needed. Most organizations similar to the Guild have adopted an annual dues collection with a common due date for all members. This allows the work of tracking the annual dues to be more focused and some steps in the process to be combined, improving efficiency and reducing workload.


The executive board, at the July meeting, decided to move to an annual due date for membership dues that is standard for all members. The intent is for the annual dues to be collected during January from all members. A notice will be sent out in early January, and all dues will be required to be paid by January 31. The intent is for this approach to apply beginning in January 2020. However, for 2020 only (a transition year), the following rules will apply.

- 1. If your annual dues were required during January 1, 2019 through August 31, 2019, you will be expected to pay your annual membership fee in January 2020.
- 2. If your annual dues are required to be paid in September, October, November, or December and you paid those dues, you may skip the 2020 payment in January at your discretion.

3. If your annual dues are required to be paid in September, October, November, or December and you did not pay those dues, your annual dues must be paid with the 2020 payment in January.

This change to the membership dues will be presented and discussed at the September meeting. If you have any feedback to the board on this change, you will be given time at the meeting to express any opinions and/or recommend changes. The amount of dues, \$25, remains the same as it has been for many years.




Double-Edged Spindle Turning Template

One year I made several identical projects for gifts. Each of them had ten spindles that I turned myself. When turning a single spindle to match a pre-determined pattern, all you really need is a ruler and caliper.

Template — But, if you're making multiple spindles, it's simpler and more accurate to transfer the pattern to a full-sized template first. Then turn each leg following the template, and they will all be identical. The template is a piece of 4"-wide poster board cut the same length as the spindle (Fig. 1). What makes this template different is that there are marks along both edges. Along one edge is a line of "tick" marks that serve as a ruler for laying out the pattern. The other edge of the guide has a series of cut-out notches used like a caliper.

Pattern Side — The pattern side of the template shows where the different contours of the leg pattern are to be positioned along the length of the workpiece. By holding this side of the template against the workpiece, the position of each contour can be marked with a pencil (Fig. 2).

Template Side — As the spindle is being turned, the other edge of the template works as an indicator gauge. It shows when you've reached the correct outside diameters of beads, tenons, and tapers, and the correct inside diameters of coves, fillets, and V-grooves (Fig. 3). A template like this helps ensure all spindles turned from the same pattern look identical.


